RE: **NEW RATE INCREASE**

THE DISTRICT HAS BEEN NOTIFIED OF A RATE INCREASE FROM SAN JACINTO RIVER AUTHORITY (SJRA). THE BOARD OF DIRECTORS OF MONTGOMERY COUNTY FRESH WATER SUPPLY DISTRICT #6 AMENDED THE DISTRICTS RATE ORDER ON 08/15/21 NEW RATE INCREASES REFLECT RATES ESTABLISHED BY SJRA WITH AN ADDITIONAL TEN PERCENT (10%)* OF THE RATE TO COVER LOST WATER AND ADMINISTRATIVE FEES. AS OF 9/1/2021 SJRA IS CHARGING THE DISTRICT TWO DOLLARS AND EIGHTY EIGHT CENTS (\$2.88) PER ONE THOUSAND (1,000) GALLONS THAT GOES THROUGH THE WELLS. (ABOVE AND BEYOND WHAT IS ACTUALLY BILLED TO CUSTOMERS.)

0 ----- 2,000 gallons \$ 60.00 (Minimum Charge)

2,001 ----- 10,000 gallons \$0.75 / 1000g

10,001 gallons ----- & over \$1.00 / 1000g

SJRA FEE \$3.16* / 1000g

TCEQ FEE 0.005 (1/2 OF 1%)

BILLING IS BI-MONTHLY (EVERY TWO MONTHS). THIS RATE INCREASE WILL BE SEEN ON BILLING YOU WILL RECEIVE EARLY DECEMBER, WHICH WILL REFLECT USAGE FROM THE MONTHS OF OCTOBER & NOVEMBER. **LATE FEES WILL BE A 15% PENALTY.** SJRA FEES APPLY TO ANY USAGE OVER THE MINIMUM GALLON ALLOTMENT OF 2,000 GALLONS.
